



How to Register for the Daikin Reimbursement Portal

OVERVIEW

This document is designed to guide you through the registration process for the Auer Steel Claim Portal. The individual who completes the initial setup will be designated as the primary user. We recommend that the owner or a member of the senior management team complete the registration. Additional users can be added later to submit claims on your behalf.

Step One - Get Started: Go to Daikin's Focus on Energy website and select Register/Submit Claim.

DAIKIN'S REIMBURSEMENT PORTAL

Daikin has partnered with EGIA to create a dealer incentive reimbursement portal. The portal simplifies the submission process and enables you to track your claim payments effortlessly. After completing an installation, submit your reimbursement claim through the portal along with a copy of your Daikin invoice. If you haven't enrolled as a participant yet, that is your first step.

On the left, enter your company credit card information (credit card will only be charged in the event of a fraudulent application to recoup awarded incentive funds EGIA does not charge fees via credit card). On the right, provide your bank details so rebate payments can be sent directly to your bank account. You'll also need to upload a copy of a voided check to verify the account.

You will receive a confirmation email from midstreamprograms@egia.org. Additionally, you will receive an email once your account has been approved. Please allow up to 1 business day for account approval.

Once you've completed and saved your profile, you can add sub-users to your account by selecting "**Click to Add Additional User**" and filling out the form in the popup. A password will be sent to the email provided. This allows multiple users to submit rebate applications and track the status of pending claims.

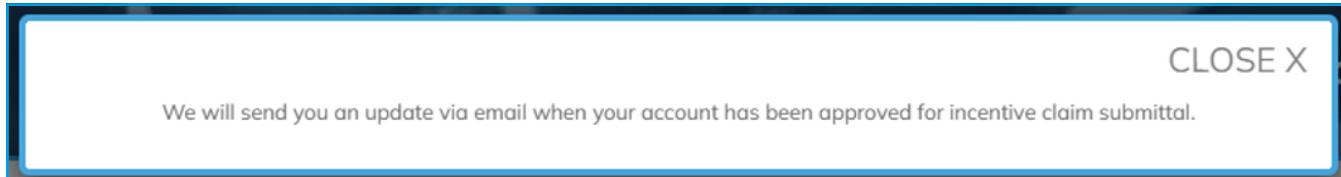
